Capital (Summer) Badminton Club – REGULATIONS

- 1. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events and/or activities shall comply with all rules and regulations posted in the facility or on the property and with all directions given by Turnbull School Ltd. and/or J.D. Turnbull Development Inc. (being the owner of 1132 Fisher Avenue and Turnbull School Ltd.'s Landlord, and being hereinafter referred to as JDT) representatives.
- All members, guests, spectators and any person attending Capital (Summer) Badminton Club's
 events or activities shall only have access to the gymnasium, male and female change rooms
 and washrooms.
- 3. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities with a motor vehicle shall not park same anywhere other than in one of the two parking lots that form part of the property and shall comply with any restrictions on parking as may be posted or otherwise designated in those lots.
- 4. All participants must change into appropriate athletic footwear and must not enter the gymnasium in shoes that have been worn outside. The use of shoes marking the surfaces is strictly prohibited. All spectators must remove their shoes before entering the gymnasium.
- 5. No food will be brought into or consumed in the gym, the washrooms or the change-rooms.
- 6. Smoking, alcoholic beverages, gambling or illicit substances are strictly prohibited within the facility or otherwise within or on the property known municipally as 1132 Fisher Avenue (the "premises").
- 7. Any participant or person attending the event or activity will be asked to leave if he or she is intoxicated and/or causing a disturbance.
- 8. All aisles, fire exits, lobbies, passageways, stairways or doorways are not blocked by participants or by anyone attending the event or activity.
- 9. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities agree not to use, store or permit to be used or stored in or on any part of the premises any flammable, combustible or explosive fluid, material, chemical or any substance prohibited by any law or by Turnbull School Ltd. policy.
- 10. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities shall not permit garbage or debris to accumulate at the facility or otherwise within or about the premises. Turnbull School Ltd. will provide a garbage bin in, or near, the gymnasium.
- 11. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities shall be solely responsible for their own safety.

- 12. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities shall comply with all laws, orders and regulations of any level of government and with any Turnbull School Ltd. policy or procedure.
- 13. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities shall not do any act which shall or might subject Turnbull School Ltd. and/or JDT to any liability or responsibility for injury to any person or persons or to property by reason of such activity.
- 14. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities shall indemnify Turnbull School Ltd. and JDT against any loss, damage, injury or death suffered by any person arising from the use of the facility or the premises and for any loss or damage to property of Turnbull School Ltd. or JDT caused by the negligence of the User, participants or any person attending the event or activity.
- 15. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities shall not damage the facility or any other property or equipment belonging to Turnbull School Ltd. or JDT. Involved Participant(s) shall assume all responsibility of any damages caused during the event or activity to the facility, property or equipment of Turnbull School Ltd. or JDT. Involved Participant(s) agree(s) to be responsible for the cost of repair or replacement of any Turnbull School Ltd. or JDT property lost, stolen, damaged, destroyed or defaced by the Involved Participant(s), any person attending the event or participant. Any such damage may be repaired or replaced by Turnbull School Ltd. and/or JDT and all costs so incurred by Turnbull School Ltd. and JDT shall be payable by the Involved Participant(s) on demand.
- 16. Capital (Summer) Badminton Club Executive Team, Turnbull School Ltd. and JDT shall not be responsible for any loss or damage, theft or destruction of the Involved Participant(s)' property or of any participant or person attending the event or activity by any cause of whatever nature nor shall Capital (Summer) Badminton Club Executive Team, Turnbull School Ltd. and JDT be liable for any latent defect in the facility, equipment or premises.
- 17. At the end of the event or activity, or upon termination of this contract by Turnbull School Ltd. and/or JDT, all members, guests, spectators and any person of Capital (Summer) Badminton Club shall ensure that all property brought to the facility or the premises is removed and that the facility is left in a clean state. All members, guests, spectators and any person attending Capital (Summer) Badminton Club's events or activities will leave the gym in the same state that it was in when they arrived (i.e. tables, chairs, equipment etc. returned to storage). Any dirts and/or damages left behind by the Involved Participant(s) agrees to pay for cleaning services if, in Turnbull School Ltd.'s opinion, it is required.

Once registration is completed, joined members automatically agree to comply with these Regulations.
